Meeting Logistics: The next regular meeting of the Red River Watershed Management Board (RRWMB) will be held at 10:00 AM on Tuesday, September 15, 2020. The meeting will be held in person and/or by electronic means at the RRWMB Office at 11 Fifth Avenue East in Ada, Minnesota.

Declaration Under Minnesota Open Meeting Law, §13D.021: Pursuant to a determination by RRWMB President John Finney that an exclusively in-person Board meeting is not practical or prudent because of the COVID-19 health pandemic, RRWMB Managers, partners, and stakeholders may participate electronically or in person in accordance with social distancing requirements.
