RED RIVER WATERSHED MANAGEMENT BOARD

## WATERSHEDS PRAISED AND AWARDED AT MAWD CONVENTION

Watershed districts affiliated with the Red River Watershed Management Board (RRWMB) received accolades at the December Minnesota Association of Watershed District's (MAWD) convention in Alexandria, MN. The convention held informative sessions on watershed issues affecting districts throughout Minnesota. State Legislative Representative Morrie Lanning of Moorhead, was the keynote speaker at the convention luncheon. Lanning praised the hard work of all watershed districts and promoted his upcoming legislative bill that would potentially organize all districts under a model presently used by the RRWMB.

Lanning also pointed out that one of the major issues prompting reorganizations is the current economic decline in state appropriated funds. By reorganizing watershed districts, the state could fund watershed districts more fully.

Lanning specifically pointed to the successes of the RRWMB model. The RRWMB is a consortium of watershed districts in the Red River valley that share costs, technical expertise, and coordination of water mitigation and flood control projects for the benefit of the entire Red River basin. Districts affiliated with the RRWMB include the Joe River, Two Rivers, Middle Snake Tamarac, Sand Hill, Wild Rice, Red Lake, Roseau, and Bois de Sioux watershed districts.

The Bois de Sioux Watershed District, headquartered in Wheaton, was recognized by the Department of Natural Resources for its excellence in water management in 2008. DNR Waters

annually recognizes an outstanding watershed district for their leadership and direction in addressing water resource management challenges.

The Bois de Sioux Watershed District was recognized for their leadership in finding watershed solutions that contribute to flood damage reduction efforts in their watershed and also benefit downstream watersheds in the Red River basin. Major projects that help store floodwaters, such as the North Ottawa Impoundment, Moonshine Lakebed Restoration, Redpath Impoundment, and Eldorado 7 are important efforts in helping solve local and regional flooding problems. The watershed district was also recognized for their active stream monitoring pro-

gram, permitting program, educational outreach efforts, and buffer incentive program and demonstrating new storm-water management applications at their new office building site.

"Our accomplishments are the results of a team effort," said Jon Roeschlein, Administrator for the district, "None of this could have been done without the working relationships developed between the staff and board of managers, local, state and federal agency field staff, but most of all the support from the residents of the Bois de Sioux Watershed District."

Convention attendees also had the opportunity to visit with exhibitors and to share their expertise about watershed issues impacting the state.

- Reviewed a letter received from the Minnesota Department of Natural Resources regarding procedures for determining conservation benefits in conjunction with the Con-Con Ditch Rule update.
